INDIAN PORT RAIL & ROPEWAY CORPORATION LIMITED (IPRCL) a first of its kind Joint Venture Company (JVC) between the Major Ports under the Ministry of Shipping and RVNL with the objective to provide efficient rail evacuation systems to Major Ports and for enhancing their capacity and throughput and to carry on the business of development, operations & maintenance of Ropeways and other modern transit systems.

The company was registered on 10th July, 2015 as a Public Limited Company under the Companies Act, 2013.

**Applications are invited from eligible candidates for undergoing one year of Graduate Engineering Apprenticeship Training at Mumbai under Apprentices Act, 1961 (as amended from time-to-time) in the trades as mentioned below:**



**A) General Conditions:**

- Age Limit:** maximum 23 years as on last date of receiving of applications in IPRCL Corporate Office, Mumbai.
- Educational Qualification:**  
At Least 60% (for candidates belonging to General Category) in aggregate of all years & semesters in Degree in Engineering granted by a Statutory University in relevant discipline. 55% in aggregate of all years & semesters in Degree in Engineering for candidates belonging to SC/ST categories.
- Training Duration:** One year.
- Reservation & Concession:** Relaxation in upper age limit 05 years for SC/ST and 03 years for OBC (Non Creamy layer).

5. Candidates whose results are awaited need not to apply.
6. Candidates having job experience of one year or more will not be eligible.
7. Candidates should not have undergone Apprenticeship Training earlier or pursuing Apprenticeship Training under the Apprentices Act, 1961 in any organisation.
8. Candidate who have passed out their Graduation in Engineering (in respective trade) on or after 01.01.2017 will only be eligible to apply. The date mentioned on the result sheet will be considered as relevant date for determining the eligibility of the Candidate.
9. Candidates must have registered themselves on National Apprenticeship Training Scheme (NATS) Portal and should have a valid Regn/ID Number of NATS that will have to be mentioned in the application form at appropriate place.
10. **Employment in IPRCL:** Candidates shall have no claim whatsoever for any extension of training and/or employment in IPRCL.

**B) Selection Procedure :**

Shortlisting of candidates will be done based on the percentage of marks obtained in the prescribed qualification as applicable to the respective disciplines and Merit List will be prepared.

No Interview will be conducted. Selected Candidate will be intimated by e-mail or through post/courier.

**C) Travel Expenses:**

No travel expenses are admissible during apprenticeship training period.

**D) Boarding / Lodging:**

Boarding or lodging will not be provided by IPRCL during the apprenticeship training period.

**E) Important: Documents to be attached with application:**

- a) Self-attested copy of Matriculation Certificate (for age proof).
- b) **Self-attested copies of Degree Certificate and mark-sheets of all the semesters for all the years in support of qualification in the respective trade.**
- c) Self-attested copy of Photo I.D. proof and address proof (Passport/Aadhaar card/Driving License/PAN card/ Voter I. Card) issued by Central/State Govt.

**F) IMPORTANT NOTES:**

- i. One envelope should contain only one application.
- ii. Applications not conforming to the prescribed format or incomplete in any respect or without self-attestation listed above shall be summarily rejected.
- iii. The responsibility of establishing the eligibility for the Graduate Trade Apprentice without any doubt shall be that of applicant by way of attaching requisite documents. The process of scrutiny of applications/documents does not involve contacting applicant or collection of additional document from applicant at any stage.
- iv. In case information furnished in the application format or the Certificates/testimonials are found to be false or incorrect, candidature of such applicants are liable to be cancelled at any stage of the selection or thereafter, besides such other penal action as deemed fit.
- v. Applicants should clearly note that IPRCL will in no case be responsible for non-receipt of their application or any postal delay in receipt thereof on any account whatsoever.
- vi. Management reserves the right to cancel/ restrict/ enlarge/ modify/ alter the selection/ engagement process at any stage, without issuing any further notice or assigning any reason thereafter.


